MEMORANDUM TO AITKIN COUNTY BOARD OF COMMISSIONERS

RE: **Public Waters Inventory (PWI) Update**

On August 15, 2025, Aitkin County was contacted by the Minnesota DNR informing us that they were beginning work on the Public Waters Inventory (PWI) Update Project. On September 18, 2025, myself and Aitkin County staff met online with DNR staff assigned to this project. On October 14, 2025, DNR staff presented the project in-person to the Aitkin County Board of Commissioners, and answered any questions they had regarding the PWI Update Project. On December 15, 2025, Aitkin County was contacted by the DNR and notified that the technical review of public waters was completed, and a preliminary map had been created. In the letter provided by the DNR, a 60 day public comment period was opened from December 29, 2025 until 4:30 p.m. on February 27, 2026. A public meeting is to be hosted and held by the DNR PWI staff at the Aitkin Public Library at 6 p.m. on January 28, 2026.

In 2017, sixteen designated public water watercourses were removed at the direction of the DNR Commissioner. According to the December 15, 2025 preliminary map of corrections, DNR staff is now recommending that sixteen be added back to the public waters inventory. The DNR staff is recommending one public water watercourse remain removed from the PWI and it is located in Section 2, Township 46, and Range 27 (Parcel ID – 07-0-002700). The Public Waters Inventory referenced in Appendix V of the current Aitkin County Shoreland Management Ordinance was not amended in 2017 to reflect The Commissioner's Order. However, Aitkin County has continued to recognize these watercourses as protected consistent with the 2017 Commissioner's Order. Therefore, no parcel will be affected by this Public Waters Inventory update.

Thank you for the opportunity to comment on the Minnesota DNR proposed Public Waters Inventory Update.

A segment of Aitkin County Ditch 37 appears as ID M-117-D001-D001 on the list of Preliminary Corrections to Public Water Inventory Aitkin County, Minnesota. This 0.32-mile segment is part of Branch 1 of Aitkin County Ditch 37 that was included in the drainage improvement petition to the Aitkin County Board on July 7, 1921 and included in the preliminary survey dated August 8, 1921. Construction of this ditch system began in June 1922 and was completed in November of 1924.

Since this segment is part of Aitkin County Ditch 37, it should not be included on the list of Preliminary Correction to Public Water Inventory in Aitkin County.

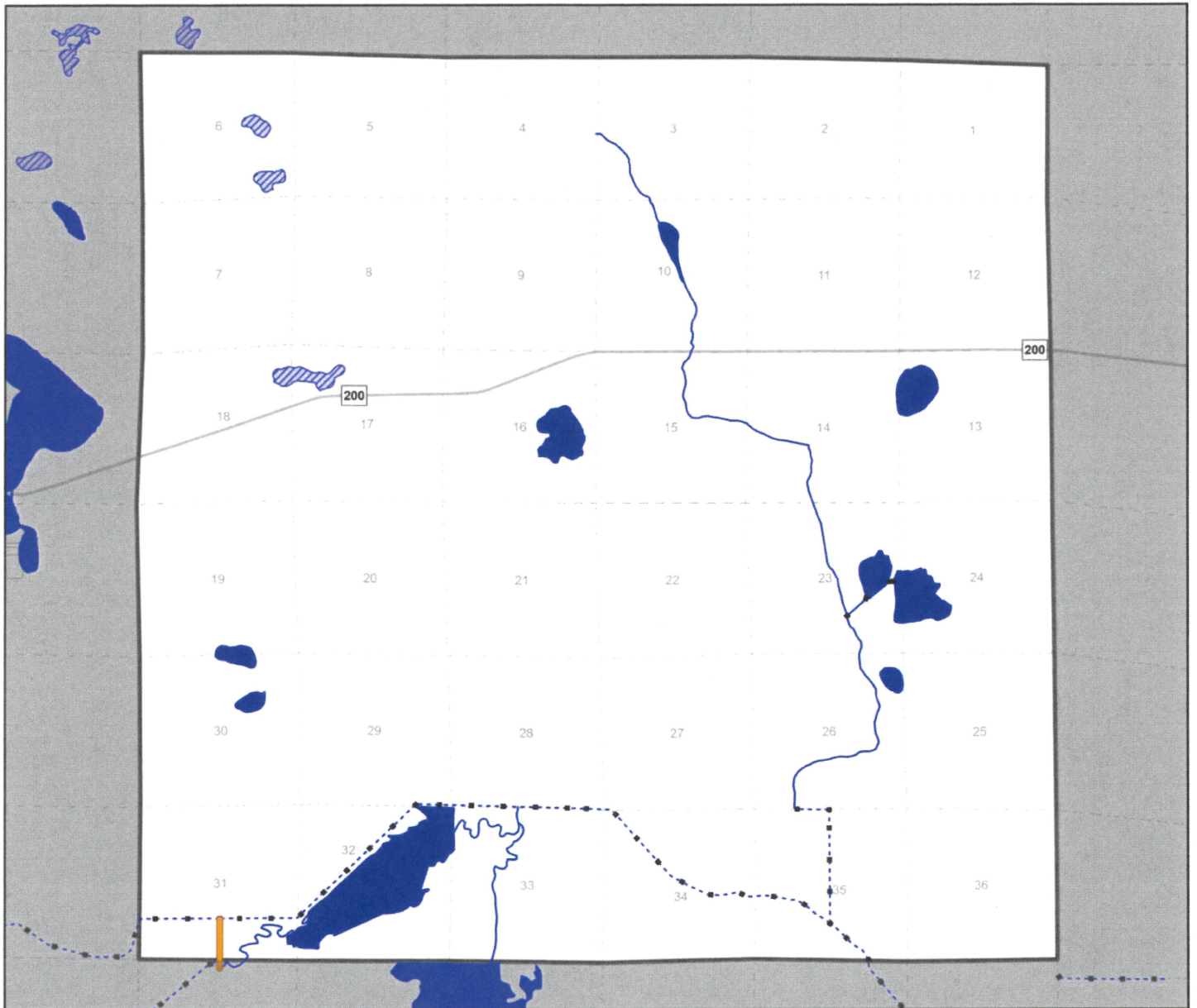

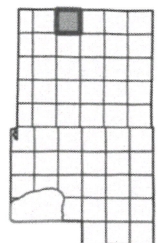
